



Registration of the companies in Bulgaria



Advantages of this jurisdiction:

- Favorable geographical position of the country makes its transport routes significant for the whole of Europe;
- Bulgaria is a member of the EU;
- The lowest corporate tax rate in the EU is fixed in the country;
- The company has the right to choose the form of accounting records maintenance (standard forms can be replaced with IFRS);
- Short terms of registration;
- Provision of national treatment to foreign businesses;
- Benefits for foreign investors who are investing large amounts in business.
- Ability to make any payments on behalf of the parent company (LP, LLP, offshore jurisdictions) on the basis of an international agency agreement.



The company in Bulgaria pays the following types of taxes:

- Income tax. It is paid by all companies that are registered in Bulgaria. Tax rate is 10%;
- Owners of any form of the company pay tax on worldwide income. The branch, accordingly, pays the tax from its own income, and the income of the parent company is not taken into account;
- The income received from the paid dividends is not included in the tax base. The withholding tax at source equals to up to 5%;
- Non-residents pay the tax on income from interest on securities and financial leasing at the rate of 10%; for the fee received for the provision of technical services in the course of transactions. The tax on the interest on the cost of leasing operations, on income from factoring and franchising, on the sale of the financial assets by the company, on income from granting of the right to exercise the intellectual rights is also paid.

VAT is paid at two rates:

- for taxable transactions of the main category - 20%;
- for export or other types of transactions provided for by international agreements - 0%.

Prices:

With the arrival of the founder of the company = **1500 EUR**

Remotely, on the basis of the notarized power of attorney = 2000 EUR

Documents:

- Scanned international passport;
- Notarized and apostillized power of attorney or legalized in the Bulgarian embassy of the country of the residence of the founder;
- If the company is registered by the founder who is a non-resident of Bulgaria, banks can take time to review the documents from two to four weeks.



Receipt of VAT number:

- Ready-made new company with VAT number - 2300 EUR (The change of the founder is included in the price);
- Ready-made new company with VAT number and account - 3000 EUR;
- Ready-made company with VAT number, experience and required activity - from 3500 to 6000 EUR, depends on the complexity of the set task.

Legal address:

- 50 EUR per month or 500 EUR for the whole year.

Accounting services:

The cost depends on the number of transactions per month and the activity of the company.

Approximate costs: from 100 EUR to 500 EUR
